#### The Sharon **And Savannah Center 'Come** Together' **With Shows**

"Rain" will play Friday at The Sharon and 'The McCartney Years" is coming to Savannah Center later this month.

Beatles fans can "Twist and Shout" twice this month in The Villages.

On Friday, the Sharon L. Morse Performing Arts Center is hosting "Rain," a multimedia musical and theatrical show in celebration of the 50th anniversary of the Beatles' "Sgt. Pepper's Lonely Hearts Club Band"

The show isn't just about that album, however.

"We'll play the album cover to cover," said Paul Curatolo, the Paul McCartney of the group. "But it tells the Beatles' career through costume changes. It's about 40 songs throughout the night everything from the first time America met the Beatles.

Curatolo said the show is a small taste of what it would have been like to see the Beatles live.

"I love seeing multiple generations in the audience getting such joy out of it," Curatolo said. "To see people sharing that with us is the best part."

The shows will be at 4 and 8 p.m. Friday at The Sharon. Tickets range from \$40 to \$79 and can be purchased at thevillagesentertainment. com or at any Villages Box Office location.

However, there is limited availability.

Later this month, the Savannah Center will host its own tribute to the Beatles with "The McCartney Years" on Feb. 24.

Yuri Pool is the Paul McCartney of this show, and he said the group's mission is to bring the music of Paul McCartney to fans and give them a night that brings back all of their fondest memories from the touring days of the Beatles and Wings.

Pool said the audience can expect to hear songs like "Jet," "Lady Madonna, "Let Me Roll It," "Maybe I'm Amazed," "Hey Jude," 'Yesterday" and more.

The group recently cele-

brated its 10th anniversary. 'We received endorsements from none other than Paul McCartney and Wings guitarist Denny Laine, and the late Beatles promoter Sid Bernstein, who called the show, 'the best on the scene," Pool said.

The band has six members, and Pool said they all are great friends who love being on the road and performing the music

they love. "I grew up listening to my dad's Beatles and McCartney records, and I still listen to the music almost every day while on the road, in a hotel or at

home," Pool said. "The McCartney Years" will be performed at 5 and 8 p.m. Feb. 24 at Savannah Center. Tickets, which range from \$27 to \$37, are available at the villages entertainment.com or at any Villages

#### Two Arrested on **Drug Charges** After Traffic Stop

A 31-year-old Summerfield man was arrested Friday at U.S. 301 and Pepper Tree Lane in Wildwood and faces pending charges of possession of methamphetamine and possession of drug paraphernalia.

According to a Sumter County Sheriff's Office report, the man was pulled over after a deputy noticed a broken tail light. The deputy requested a K-9 officer, which alerted deputies to narcotics. Upon searching the vehicle, deputies found a small clear plastic baggie containing a white powdery substance, which field-tested positive for methamphetamine, according to the report. Deputies also found a light blue straw coated with residue.

The defendant was arrested and booked on \$3,000 bond. A passenger, a 19-year-old man, was arrested for possession of drug paraphernalia and

Sumter County Sheriff's deputies arrested a Lady Lake man Sunday on charges of drug possession and driving with a revoked license.

Around 11 a.m., deputies stopped the 34-year-old man near County Road 100 and Northeast 106th Lane after discovering one of his brake lights was out, according to an arrest report.

The man behaved aggressively and deputies could smell a "strong, pungent odor" of marijuana from inside his vehicle, the report stated.

A check of the man's driver's license found it was revoked as a habitual traffic offender, the report

stated. After placing the man under arrest, deputies searched his vehicle and found three smoked marijuana cigarettes, a digital scale and a black plastic bag containing marijuana, prescription drugs, cocaine and methamphetamine, the report

He was booked at 12:44 p.m. Sunday at the Sumter County Jail. He was released that night on \$20,000 bond.




